



Checklist for visa application in Georgia for sport events

(including persons accompanying in a professional capacity)

Applications should be submitted in person (also babies and children) and the following documents must be submitted:

- For every document, you must provide the original and one copy.
- The documents are to be presented in (or translated to) Dutch, English, French or Spanish.
- The documents submitted will not be returned. Only the travel document will be returned.

1. Application

- 1.1 A completed and signed Schengen [visa application form](#).

2. Travel Documents

Please note:

- Your passport or travel document must be valid for at least 3 months from the date on which you leave the Schengen area.
 - Your passport or travel document must have at least 2 empty visa pages.
 - Your passport or travel document cannot have been issued more than 10 years ago.
- 2.3 Specific requirements for minors: The consent of the parental authority or legal guardian should be required only if the minor travels alone or only with one parent. Obviously exceptions should be made to this, if the single parent with whom the minor is to travel holds the parental authority alone.

If the sports person covers the costs: his/hers bank statement demonstrating the last three months' account movements.

- 5.6 Recent employment certificate (in case of company owners – registration of the company indicating that the applicant is the owner) and/or title of property ownership in Georgia.
